**FLEA MARKET CONTRACT CONDITIONS**  
**TO BE READ BEFORE SIGNING CONTRACT**

**TRASH:** All vendors are responsible to clean up the spot(s) they have rented. There is to be no food, garbage, boxes, bags, bottles or articles of any kind left behind. Pails will be provided for soda cans or scraps. Anyone not cleaning up their spot(s) will be charged and extra \$10 when booking each and every other future date.

**NO REFUNDS:** If you have paid for a spot(s) for a specific date, there will be no refund or use of money paid to be put to a future date. **There are no refunds.** This is unconditional regardless of any circumstances.

**RACKS AND HANGING ITEMS:** Absolutely no racks of any kind allowed. Nothing is to be hung from the drapes or walls. Nothing is to be placed on window sills, the stage, taped to walls, or bulletin boards, etc. You are renting a table, **ONLY!**

**PARKING:** There is a limited amount of paid parking spaces available. These spaces are available on a first come, first serve basis, with a charge of \$15.00 per space. There is a strict tow policy which will be enforced if there are violations of our parking policy. The tow charges are the responsibility of the owner of the illegally parked vehicle. **We have no responsibility for your car if it is damaged in the parking lot.**

**TIME:** All vendors are to use the Bay 19<sup>th</sup> Street parking lot entrance only. The Bath Avenue doors will not be opened until later in the AM. Doors for vendors will open 7:15AM – 7:30AM. All merchandise must be brought in through parking lot doors. There is to be no blocking of these doors with your merchandise. There is to be no blocking of other vehicles while you are unloading. The Flea Market is over at 3PM. **Vendors must be packed and off premises by 4PM – no exceptions!**

**RESPONSIBILITY:** As you know, shoppers are on hand from the time we allow them to enter and often sneak in prior. Be aware of this and be alert! We are not responsible for your merchandise or your money. **Your table security is your responsibility!** We are not responsible for any damages to merchandise. No one is to sit on their table or set up chairs in the aisle, blocking the aisle. Anything placed under your table should not be sticking out in the aisle. Used clothing must be clean, and not stacked higher than 12 inches. All merchandise should be presented in an orderly, neat fashion. We fully endorse vendors having a reasonable return policy on sales. If there are disputes over return policy and a reasonable conclusion is not forthcoming, Flea Market personnel will have the last word on settlement.

**PAYMENT:** Our tables go very quickly, as our Flea Market is well advertised and one of the very best. It is wise to book your table(s) well in advance.
